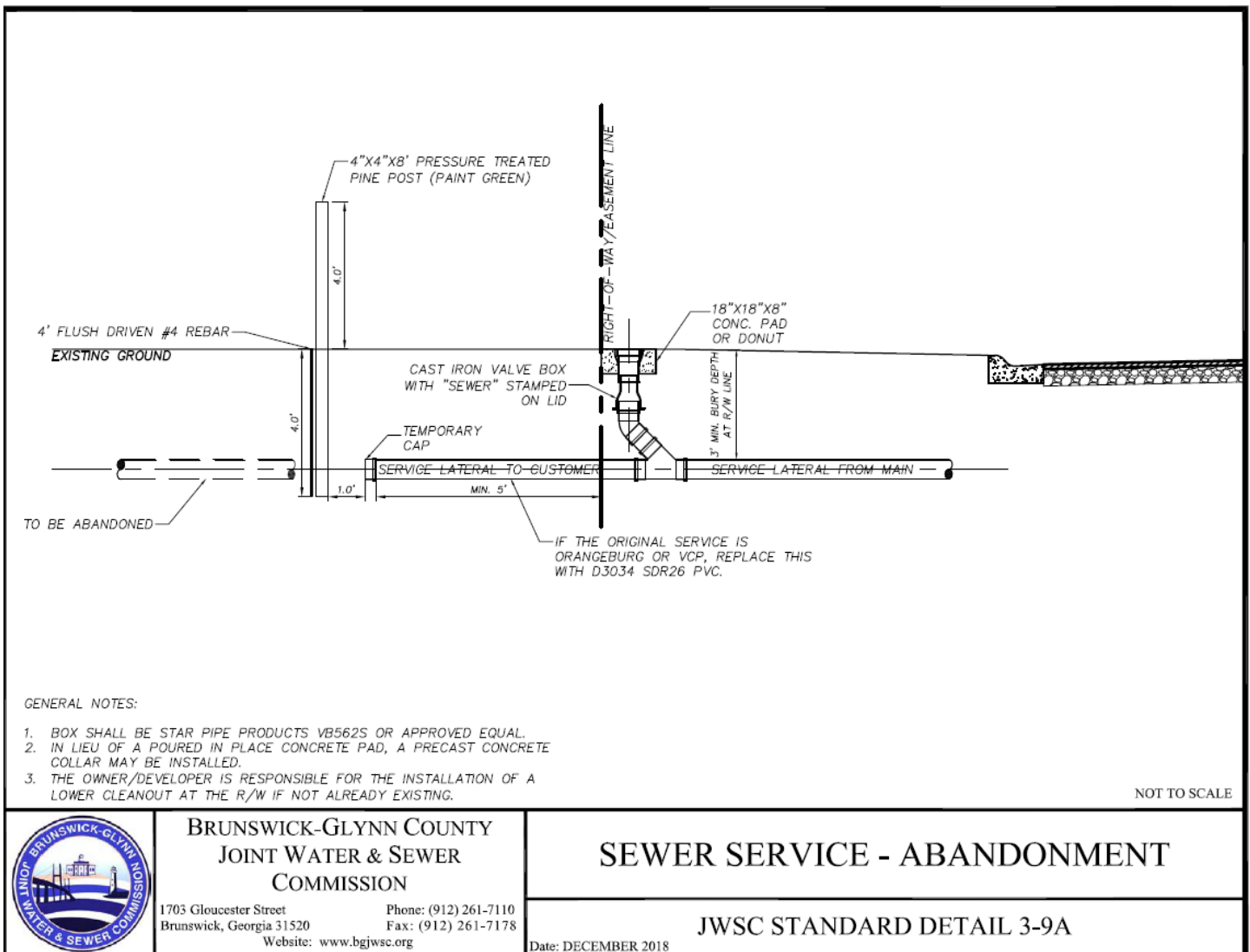




## DEMOLITION APPLICATION

**Follow these steps AFTER filing a Demolition Permit with  
 Glynn County Development or the City of Brunswick**

- Complete the JWSC Demolition Application
- If applicable, make payment of the \$165 Sewer Inspection fee
- Following JWSC Standard Detail 3-9A Rev Dec 2018 (inserted below), prepare the demolition site
  - Cut and cap the sewer lateral
  - Add a clean-out at the Right-of-Way with donut
